Rental Fee: Early Bird Special: \$30 (must be postmarked on or before March 25, 2009); March 26 –April 17, 2009, \$40  
Late Registration: April 18, 2009 – day of fair, \$50

### FAIR RULES

1. All vendor/exhibitors are **REQUIRED** to use a tent or awning in their rented space.
2. Space rental entitles vendor/exhibitor to have two people to sell at a booth (space). Individuals may purchase tickets to be eligible for door prizes to be drawn during the Fair. Admission to the fairgrounds is free.
3. Spaces will be pre-assigned on a first-come basis. This is determined by receipt and approval of application, NOT on arrival at the fair. Preferences will be considered but are not guaranteed. Booth space is limited to the first 75 applicants.
4. The Bullock County Historical Society will assume no responsibility for damages, loss or theft of merchandise.
5. No auto traffic will be allowed in the Fair area after 8:30 a.m. Only pre-registered vendor/exhibitors will be allowed to set up before 8 a.m. All vendor/exhibitors registering the morning of the fair will be required to set up between 8 and 8:30 a.m.
6. This is a JURIED FAIR with first and second place cash awards for 1) fine art and 2) craft and a cash award for Best of Show. In addition, a cash prize will be rewarded for the Best Booth.
7. Deadline for registration will be Friday, April 17, 2009. Exhibit fees are not refunded to Exhibitor because of cancellation on Exhibitor's part.
8. Notification of cancellation of Fair due to bad weather will be on Friday, April 24, 2009.
9. Confirmation will be mailed or emailed upon request.
10. Merchandise vendor/exhibitors are required to provide tablecloth or some other type covering for display tables and an awning or canopy for your space.
11. A Vendor/Exhibitor Only hospitality room will be provided. Vendor/exhibitors must have vendor/exhibitor badge to enter. Two badges per space will be provided at check-in the morning of the fair.
